- Will small businesses be required to obtain a business license? If so, who will handle this?
- How are other Counties handling zoning?
- Who is qualified to enforce?
- Who will pay for this?
- Will taxes go up?
- Is it possible to have a referendum placed on the ballot for citizens to vote on?
- How many people will zoning add to the payroll?
- When will the citizens get answers?
- Why are we having a meeting about zoning if we do not have a proposal?
- Will there be someone to do a study?
- Do we want to be protected?
- Without zoning, can we stop unwanted industry?
- Are we going to add zoning because other counties have it?
- Will there be an out of County inspector?
- Where are we going and how are we going to get there?
