# Board of Commissioners of Candler County Called Meeting/Budget Workshop June 13, 2017 1:00P.M.

The Board of Commissioners of Candler County held a called meeting on Tuesday, June 13, 2017, at 1:00 p.m., in the Commissioners' boardroom at 1075 East Hiawatha Street, Suite A, Metter, Georgia. The purpose of the called meeting was to discuss the proposed County Maintenance and Operations and Special Revenue budgets for the 2018 fiscal year. Those attending the meeting were Candler County Vice-Chairman, Brad Jones, who arrived after the meeting was called to order. Candler County Commissioners Donny Wells, David Robinson and Wayne Culbertson; Candler County Administrator, Doug Eaves; Candler County Clerk, Maranda K. Lank; Candler County Attorney, Kendall Gross. Guest attending the called meeting included Candler County Registrar Board member, Gary Allen; Angie Daughtry, UGA Ag Extension Office and Glenn Deal. County Commission Chairman, Glyn Thrift, was unable to attend the meeting. The Metter Advertiser was notified, but had no representative present for this meeting.
