Chairman Glyn Thrift presided with Commissioners Gregory Thomas and Blake Hendrix in attendance. County Administrator Bryan Aasheim and County Attorney Kendall Gross also attended the meeting. Clerk Kellie Lank scribed. The Metter Advertiser was notified of the meeting. Jerri Goodman attended. Guests attending this meeting included: Candler County Sheriff John Miles. This meeting was offered via teleconference to the public.
