The Board of Commissioners of Candler County met for a called meeting on Monday, December 13, 2021, at 5:00 p.m., in the Commissioners' boardroom at 1075 East Hiawatha Street, Suite A, Metter, Georgia. Chairman Glyn Thrift presided with Vice-Chairman Brad Jones, Commissioners Gregory Thomas, David Robinson and Blake Hendrix in attendance. County Administrator Bryan Aasheim and Attorney Cindy Delgado sat in for County Attorney Kendall Gross. Clerk Kellie Lank scribed.

The Metter Advertiser was notified of the meeting but had no one in attendance. There were no citizens present at this meeting. This meeting was offered via teleconference to the public. However, no citizens signed on to hear the meeting.

Call to Order

Chairman Thrift called the meeting to order at 5:04 p.m.

Invocation and Pledge of Allegiance

Commissioner Thomas delivered the invocation and Chairman Thrift led the *Pledge of Allegiance*.


To review and adopt proposed redistricting maps based on the 2020 Census data

Mr. Aasheim presented the redistricting maps that were furnished to Candler County by the State of Georgia Legislative and Congressional Reapportionment Office. Chairman Thrift opened the floor for public input. However, there were no citizens present nor were there any citizens signed on via teleconference to participate in the meeting. A Public Notice of this meeting and an article with the proposed maps were published in the December 8, 2021 edition of the Metter Advertiser.

Commissioner Robinson made a motion to adopt a resolution and approve the maps provided by the State of Georgia Legislative and Congressional Reapportionment Office reflecting the population changes as reflected in the 2020 Decennial Census and advertised in the Metter Advertiser. Commissioner Hendrix provided a second to the motion. The motion carried 5-0. (Exhibit A)

WHEREAS, Candler County, Georgia is committed to the principle of one person, one vote; and

WHEREAS, the 2020 Decennial Census identified a change in demographics over the existing four districts of Candler County, Georgia; and

WHEREAS, Candler County, Georgia has requested the staff of the Legislative and Congressional Reapportionment Office to create a map showing changes to said voting districts; and

WHEREAS, the Legislative and Congressional Reapportionment Office has prepared a map that illustrates the demographic changes to the district of Candler County, Georgia;

WHEREAS, the Commissioners of Candler County, Georgia believe that said proposed changes would better reflect the principle of one person, one vote.

IT IS NOW, THEREFORE, THE RESOLUTION OF THE CANDLER COUNTY COMMISSION as follows:

1. The map attached hereto as Exhibit A showing the Candler County Commission proposed districts is hereby approved following a public hearing that was advertised in The Metter Advertiser, the legal organ for Candler County, Georgia.
2. The Candler County Commission, by this approval, recommends the proposed changes as shown on said map to the Georgia Legislature.

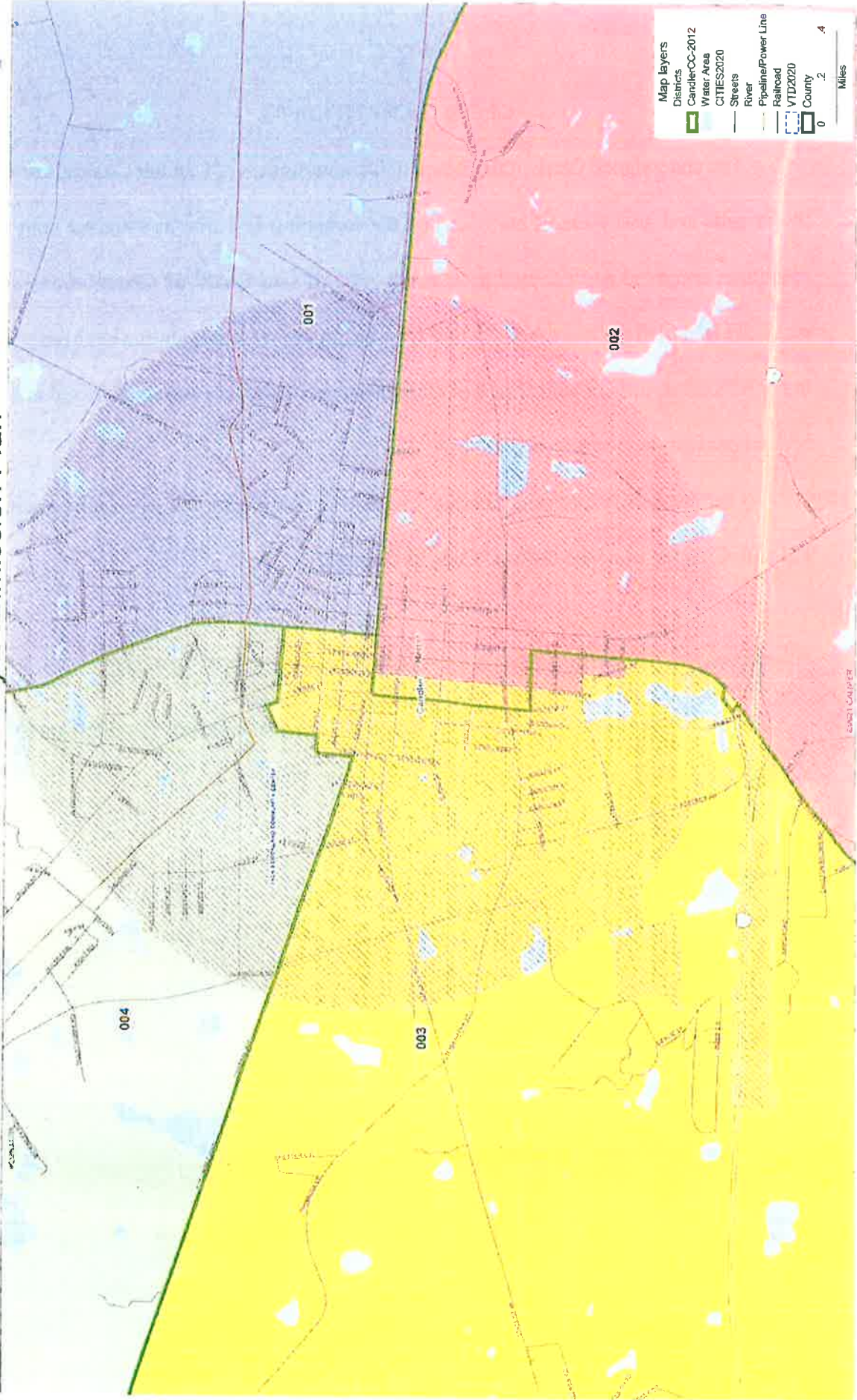
