The Board of Commissioners of Candler County met for the regular monthly meeting on Monday, March 20, 2023, at 5:00 p.m., in the Commissioners' boardroom at 1075 East Hiawatha Street, Suite A, Metter, Georgia. Vice-Chairman Brad Jones presided with Commissioners Gregory Thomas, David Robinson and Blake Hendrix in attendance. Also attending were County Administrator Bryan Aasheim, County Clerk Kellie Lank and Attorney Cindy Delgado attended for County Attorney Kendall Gross. The Metter Advertiser was notified of the meeting, Jerri Goodman attended.

Guests attending this meeting included: Jean Melton Furr, Shelly Eickenberg and Daniel Chicola with EMC Engineering Services, Inc.

Call to Order

Vice-Chairman Jones called the meeting to order at 5:00 p.m.

Financial Report

Old Business

Candler County Zoning Ordinance - Proposed

Administrator Aasheim requested tabling the Candler County Zoning Ordinance until April 17, 2023. He then explained HOGARC continues to work on making the requested changes to the draft ordinance and updating the maps with an estimated delivery date in late April.

Commissioner Robinson made a motion to table the Candler County Zoning Ordinance until the April 17, 2023 meeting. Commissioner Thomas provided a second. The motion carried 4-0.

Candler County Jail Housing and Support Building - Proposed

- Consideration of a proposal from Studio8 Design for an architectural design agreement Administrator Aasheim presented a proposal from Studio8 Design for architectural design. He stated the County Attorney and himself are working together on steps to revitalize the Candler County Public Building Authority. A discussion took place on the estimate increase from two years ago (\$12.5M to \$14.5M) and funding of the facility. Administrator Aasheim went on to say although the \$10,396.01 seems expensive, the three Power Load Cots and one Power Pro Cot are medical stretchers that carry people and to have the regular maintenance and certification on them from the provider that they are functioning properly is desirable.

Proposal for Chemical Grouting Soils and Leak Seal Around Culvert Pipes

JOB SITE:

TBD Candler County, GA

SCOPE OF WORK:

Based on an interview with the customer's engineering representative the soils around double 48-inch diameter RCP pipes measuring approximately 65 feet in length are showing signs of erosion. The pipes serve as a culvert for a seasonal stream flowing under a county-maintained road. The pipes are approximately 2-3' below the surface of the road. The signs of erosion at the surface are reported near the upstream end of the pipes where the road shoulder and some of the road itself has dropped 1-2" from original grade.

The objective of the grouting course will be to inject water-reactive polyurethane resin to stabilize soils, fill voids and seal any leaking joints in the RCP. This grouting course will prevent additional sinkholes and settlement as well as strengthen and consolidate existing soils and extend the life of the pipes and road above. The grout will be injected through driven rods inserted approximately 5-7 feet in depth from road level. Insertions will be made on two-foot centers on either side of the pipes and one injection between the two pipes. Material will be injected at 3 gallons per point.

Proposed chemical grout is water reactive Alchemy-Spetec polyurethane resin, AP Fill 720. AP Fill 720 is a product designed to react when it comes in contact with water, where it then expands, displaces remaining water (hydrophobic), seals leaks, stabilizes soils and fills voids.

***Please note AP Fill 720 is non-hazardous and non-toxic. It is NSF / ANSI 61 approved - safe for contact with potable water.

SiteMix Pressure Grouting, LLC., hereinafter referred to as SPG, proposes to furnish a working crew of three (3) men including an experienced superintendent plus the following:

- 1. Chemical grout pump and hoses
- 2. Necessary power tools including drills.
- 3. AP Fill 720 Polyurethane resin

CONTRACT TIME:

It is understood the work to be performed is in one continuous operation.

PRIOR NEGOTIATIONS:

All prior negotiations, proposals, correspondence and memoranda between Buyer and SPG are superseded by this proposal. This proposal, in its entirety, shall be made an integral part of and incorporated into any purchase order, proposal or contract agreement resulting from it. SPG's offer is subject to possible revision in Scope, Price and Terms if not accepted in writing by Buyer within 30 days.

PRE-BID INFORMATION:
