The Board of Commissioners of Candler County met for the 2024 SPLOST meeting on Monday, May 1, 2023, at 3:00 p.m., in the Commissioners' boardroom at 1075 East Hiawatha Street, Suite A, Metter, Georgia. Those attending the meeting were Candler County Chairman Glyn Thrift; Candler County Vice-Chairman Brad Jones and Candler County Commissioners David Robinson and Blake Hendrix; Candler County Administrator, Bryan Aasheim; and Candler County Clerk, Maranda K. Lank. Commissioner Gregory Thomas and County Attorney Kendall Gross did not attend this meeting.

Guest included Mayor Paul Greene and Councilperson Ruth Deloach representing from the Pulaski Town Council as well as Mayor Ed Boyd and City Manager Carter Crawford from the City of Metter. The Metter Advertiser was notified, but had no representative present.

Call To Order

Chairman Thrift called the meeting to order at 3:30 p.m.

24SPLOST

Administrator Aasheim opened the initial meeting for establishing the Call for Election for a new SPLOST referendum. Aasheim submitted Exhibit A to the Board of Commissioners, the Metter City and Pulaski Town Councils. The anticipated '24SPLOST proceeds of \$10,800,000.00 distributed to each of the governmental bodies based on the 2020 Census population would be collected over a six-year period. Mayor Boyd submitted Exhibit B and requested funding for the Industrial Development Authority and the Metter-Candler Airport Authority. Mayor Boyd further requested restructuring the payments so that the IDA receive monthly payments as the governmental bodies do.

Adjournment

With no further business to discuss, Vice-Chairman Jones made a motion at 4:47 p.m. seconded by Chairman Thrift to adjourn the meeting. The motion carried unanimously.
