Chairman Jones entered executive session at 9:33 a.m.

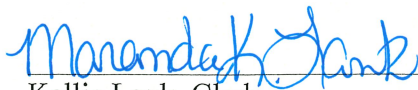

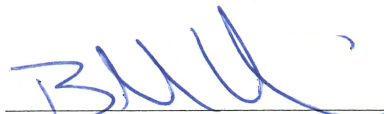
No Action taken after Executive Session.

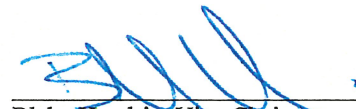
