AMENDMENT TO THE ORDINANCE CREATING A BUSINESS AND OCCUPATION TAX FOR THE UNINCORPORATED AREAS OF CANDLER COUNTY, GEORGIA

WHEREAS, on April 1st, 2013, the Board of Commissioners of Candler County, Georgia enacted an Ordinance creating and implementing a tax on businesses and occupations in the unincorporated areas of Candler County, Georgia; and

WHEREAS, the Board of Commissioners has determined that it is in the best interests of the citizens of Candler County, Georgia to amend said Ordinance; and

WHEREAS, after having reviewed the penalties to be imposed in the event of a violation of the Ordinance, has determined to reduce said penalties; and

WHEREAS, after considering the enforcement of said ordinance, has determined that it should modify the vehicle for the enforcement of said ordinance; it is

NOW, THEREFORE, resolved to amend said ordinance as follows:

(1) Section 6 is hereby repealed, and the following language shall be inserted into said ordinance:

The penalty for violating this ordinance shall be \$25.00. Each day a business owner is in violation of this ordinance shall constitute a separate violation. This ordinance shall be enforced in accordance with the laws of the State of Georgia.

(2) Section 5 of said ordinance is hereby repealed, and the following language shall be substituted in its place:

In the event a business is located in the unincorporated areas of Candler County, Georgia, and should fail to pay the tax imposed by this ordinance, the County Code Enforcement Officers, or the Sheriff of Candler County, Georgia shall be authorized to issue a citation to each such business owner for each such day said business owner is in violation of this ordinance. Any citation issued under this section shall be returned to the Magistrate Court of Candler County, Georgia.

Any provision of the ordinance modified herein that conflicts with this modification is hereby repealed. This modification shall go into effect on August 7th, 2017.
