The Candler County Board of Commissioners is seeking proposals for replacement of fencing at the Metter-Candler Recreation Department. Sealed proposals shall be received until 3:00 p.m. on Friday, August 27, 2021:

Proposals shall be labeled "Metter-Candler Rec Department Fencing". Proposals received after the deadline will not be considered.

The Scope of the Proposal shall be as follows:

- Replace all baseball field fencing on fields 1, 2 & 3 to include all backstop areas;
- All proposals shall be for 2" chain link fencing, 9-gauge, black vinyl
- All proposals shall include removing the old fencing, replacing with black vinyl, including dugouts and backstops and adding two support rails to each backstop area for additional support

Bidders shall include an add alternate proposal(s) as follows:

Alternate #1 - Paint all fencing support poles on fields 1, 2 & 3 with black paint to match fencing

Alternate #2 - Move existing fencing on old Metter High School Field and add additional fencing as necessary to extend fence coverage to Pine St. & Register St.

Proposals must contain a unit price, Insurance Certificates, the names of all owners of the company.

Contractor must agree to indemnify and hold harmless Candler County and all employees, offices and agents from any and all losses resulting from the completion of this work scope. The Contractor will work as a separate agent from Candler County and shall provide to the County Certificates of Insurance for both General Liability in the amount of \$1,000,000 per occurrence and Worker's Compensation Coverage to the limits required by Georgia law. Insurance Certificates must be submitted with the bid documents.
