3. Vehicle shall be ready for use upon delivery;

These are the minimum specifications and all deviations should be listed in the proposal and identified as such including an explanation for the deviation. Please include deviations along with supporting information (chassis or body build sheets) on the unit you are bidding.

**HEAVY DUTY CONSTRUCTION DUMP TRUCK**

Bid Specifications shall be consistent with the standard configurations for production heavy duty dump construction vehicles of this type, including, but not limited to:

<b>AXLE CONFIG:</b>	6x4
<b>APPLICATION:</b>	Construction Dump
<b>GVWR:</b>	66,000
<b>GCWR:</b>	140,000
<b>ENGINE, DIESEL:</b>	Cummins X15 470V, 470HP @ 1900 RPM, 1750 lb-ft Torque @ 900 RPM (OR COMPARABLE MODEL/SPECIFICATIONS)
<b>TRANSMISSION, AUTOMATIC:</b>	Allison 4500 RDS (OR COMPARABLE MODEL/SPECIFICATIONS)
<b>DUMP BODY:</b>	Duraclass (or comparable) 16' X 84", steel floor, LED lights, 54" tall sides, spreader chains, tarp assembly with tarp, back up alarm, mud flaps, vibrator, swing gate, high lift gate

**PURCHASE:**

Vendor/Bidder shall provide, if available, 60-month lease/purchase (governmental entity lease) terms for the proposed unit including all maintenance costs.

- Lease payment may include or have a separate mileage component.
- All maintenance costs, excluding tires, shall be included in the lease cost (per month)
- Bidder shall designate in the bid where maintenance shall occur
- Bidder shall provide and acknowledge lease terms regarding vehicle “down time” for maintenance during lease period.
