Candler County is seeking proposals for the services of Wood Storm Debris Grinding & Vegetative Debris Grinding and disposal. Sealed proposals shall be received until 3:00 p.m. on Friday, March 1st, 2019:

Proposals shall be labeled "Candler County Storm Debris Grinding". Proposals received after the deadline will not be considered.

Services shall include Storm Debris Grinding Services:

The scope of work is defined as work eligible under FEMA Public Assistance regulations, policy and guidance

Provide mobile on-site storm debris grinding services at the Candler County Landfill located at 842 Landfill Rd. Metter, GA

Remove non-organic material from the debris pile as needed. Non-organic debris can be disposed of at the Candler County Landfill

Manage vegetative debris pile by pushing the material back and up to keep driveways clear to the unloading sites and to keep brush pile contained;

Grind debris waste to final product, load product and transport to the Inert Landfill located on site;

Clean debris area to soil exposure, grade as necessary to remove ruts and bumps.

The Estimated tonnage is 103 tons. Proposals should include a per ton cost. Contractor shall provide all equipment, vehicles, fuel, oil and lubricants required for the provision of the service.

Once service has commenced all work shall be completed within fourteen (14) days.

Proposals must contain a unit price, Insurance Certificates, the names of all owners of the company and to be completed by timeline after notification of award.

Contractor must agree to indemnify and hold harmless Candler County and all employees, offices and agents from any and all losses resulting from the completion of this work scope. The Contractor will work as a separate agent from Candler County and shall provide to the County Certificates of Insurance for both General Liability in the amount of \$1,000,000 per occurrence and Worker's Compensation Coverage to the limits required by Georgia law. Insurance Certificates must be submitted with the bid documents.
